

Resolution 02-07-06-02
An Amendment to Resolution 040405-01 Establishing Fees and Charges
Pursuant to Section 54-161 of the Municipal Code of the Village of Fontana on Geneva Lake;
Specifically Launch Fees

Whereas, the Village Board has the authority pursuant to Section 54-161 for the Municipal Code to set user fees, charges and hours for a variety of services offered and related to the public waters and beaches in the Village of Fontana on Geneva Lake; and

Whereas, the Wisconsin Department of Natural Resources recently established new maximum rates for launch ramps located in the State of Wisconsin; and

Whereas, the Lakefront and Harbor Committee has recommended to the Village Board that the Village of Fontana on Geneva Lake amend our existing launch ramp fees to accommodate the new maximum rates set by Wisconsin Department of Natural Resources for non-resident rates and increase the resident rates, but not to the maximum level; and,

Whereas, the Village Board does change the fees, charges, and hours from time to time as authorized by the Municipal Code; and

Now Therefore, Be it Resolved by the Village Board of the Village of Fontana on Geneva Lake that the fees, charges, and hours as authorized by Section 54-161 shall be amended for the 2006 season and subsequent years until again set by the Village Board as set forth in the attached Exhibit "A".

These fees shall remain in force until again set by the Village Board.
