President Petersen/Chairman Spadoni 2nd made a MOTION to approve the minutes for the Plan Commission meeting held December 27, 2012, and the MOTION carried without negative vote.

<u>**Joint Session General Business**</u>

Codification of Existing ETZ Zoning Code

Village Attorney Thorpe stated that the Village of Fontana adopted a rewritten Zoning Code in 2012 and as part of that project, the existing Extraterritorial Zoning District Ordinance, including the five previously approved zoning amendments, was renumbered and formatted into the new Village

Zoning Code. Thorpe stated that the intent of the agenda item is to generate a written record of the ETZ Committee's authorization to codify the existing ETZ Code and the previously approved ordinance amendments into the new Village Zoning Code. Village Planner Mike Slavney stated the ETZ Section was just renumbered and incorporated into the new outline format.

Village of Fontana representative Lobdell/Village of Fontana representative Vilona 2nd made a MOTION for the Joint ETZ Committee to recommend in favor of the reformatted and renumbered Exterritorial Zoning Ordinance as presented in the draft ordinance dated December 18, 2012, and the Roll Call Vote was as follows:

The MOTION carried on a 7-0 vote, with Village of Fontana representative O'Connell and Walworth Township representative van Dreser absent.

<u>President Petersen/Commissioner Frazier 2nd made a MOTION to recommend Village Board</u> approval of the reformatted and renumbered Exterritorial Zoning Ordinance as presented in the draft ordinance dated December 18, 2012, and the MOTION carried without negative vote.

Proposed Amendments to ETZ Code – Joint ETZ Committee Schedule Public Hearing

Thorpe stated that he outlined corrections or updates to the existing ETZ Ordinance in a memorandum dated September 3, 2011 that was distributed at the meeting. Thorpe stated that four of the proposed amendments outlined in the memo do not rise to the level of substantive material changes to the ETZ ordinance, but seven other amendments outlined in the memo are substantive and are required to be reviewed at a public hearing and approved in a housekeeping extraterritorial zoning ordinance amendment. Thorpe stated that the proposals in the memo need to be drafted into the ETZ Ordinance and then set for a public hearing before the ETZ Committee and the Plan Commission. Spadoni asked Thorpe if the public hearing could be authorized that night without the draft of the proposed amendments as long as the draft is ready by the time the public hearing notice is published in the newspaper. Slavney stated that the computer server problems his firm is experiencing have almost been resolved and he will draft the proposed amendments to the ETZ code as soon as possible. As soon as the draft is completed, it will be distributed to the Plan Commission and ETZ Committee members and the public hearing will be scheduled. If the draft of the proposed amendments is completed prior to the newspaper publication date of February 7, 2013, the joint public hearing will be scheduled for Monday, February 25, 2013 beginning at 5:30 pm at the Fontana Village Hall.
