#### **Present Website Quotes**

Idea Marketing-\$16,000.00 (recommended by VOF's IT company)

Civic Plus-\$25,000.00+ (national municipal website company)

Signal Fire-\$16,000.00 (local)

Commissioner Vilona stated that staff would do a thorough review and make sure they are offering "apples to apples" and then bring a recommendation back to the Tourism Commission at the next meeting. It was also stated that the decision should go through Finance Committee as the Tourism Commission will fund up to \$13,000.00 from excess room tax per Act 55 requirements and the difference in cost will be funded by the General fund.
