General Permit Requirements

1. Before a permit is issued, a cash deposit or a bond in the amount of \$15,000.00 shall be filed by the applicant with the Village in support of the application for permit described herein. If a bond is submitted, said bond shall be executed by a licensed surety company acceptable to the Village as a guarantee that the applicant will comply with all Village ordinances relating to such permit and will maintain and restore the area excavated pursuant to the permit and thereafter maintain the same and provide a guarantee for a period of one year following completion of the excavation. In the event the Village determines that the excavation proposed requires a cash deposit or bond in excess of \$15,000.00, then the bond provided shall be for the amount so determined.
2. Prior to commencement of excavation work, the permittee shall furnish the Village with satisfactory written evidence that said permittee has in force and shall maintain during the life of the permit and the entire period of the excavation, public liability insurance of not less than \$100,000.00 for injury to one person, \$300,000.00 for one accident, and property insurance of not less than \$50,000.00.
3. Applicant must contact "Diggers Hotline" at (800) 242-8511 three (3) working days before you dig.
4. Applicant shall notify the Dept. of Building and Zoning 48 hours prior to commencement of the work.
5. Work zone signing and barricading shall be in accordance with the Wisconsin Manual On Uniform Traffic Control.
