John Cameron from Ehlers provided an overview of the bond sale report. The total amount of bonds issued were \$10,100,000 to low bidder Robert W. Baird & Company, Incorporated, Milwaukee, Wisconsin, at the rate of 2.2548%. The report states, "The total principal and interest over the life of the debt is \$377,849 lower than presale estimates due to a premium received and lower interest rates over planning estimates." Prior to the sale, Moody's Investor's Service rate the Village at a Aa3 rating. The Complete Sale Day Report is on file at Village Hall.
