The monthly meeting of the Lakefront and Harbor Committee was called to order at 4:00 pm on July 25, 2018 by Bob Chanson.

General Business

Approval of Minutes for June 27, 2018

Snyder/Beers 2nd made a MOTION to approve the minutes from the June 27, 2018 meeting, and the MOTION carried without negative vote.

Launch Update – Greg Blizard

Blizard stated the nine days over Fourth of July went well and traffic was handled appropriately. Blizard stated the launch lost one of its retired staff members who had been available when the student employees were in school, and those employees in school will be leaving by the end of next month which might create staffing issues at the launch.

Discussion on Ordinance to Regulate Boat Rentals

An individual from Buena Vista Club has been operating a boat rental business from the village launch. This does not violate any ordinance but holds up the launch at times and creates a nuisance for other boaters trying to launch.

Chanson/Snyder 2nd made a MOTION to recommend that the Village Board direct the Village Attorney draft an ordinance to restrict boat rentals from occurring on the municipal piers, and the MOTION carried without negative vote.

Discussion on Height & Placement of F-Sticker Only Parking Signs

The committee discussed the height of the F-Sticker Only signs and Chief Cates stated they were intentionally placed low as to not obstruct the view of the lakefront. Discussion ensued on the penalty for parking illegally and the committee agreed to recommend raising the parking citation rates from \$15 per day to \$25 per every four hours.

Chanson/Beers 2nd made a MOTION to recommend the Village Board increase parking citation rates from \$15 per every 24 hours to \$25 per every four hours, and the MOTION carried without negative vote.
